## Call to Order and Pledge

Chairman Felch called the meeting to order at 2:00pm on Thursday, May 16, 2024. ## Approval of Agenda

Since it is native to us, we are trying to plant the Coastal Blue Stem grass that the butterfly lays its eggs in and has two lifecycles in a season.
